1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. I am 48 years of age.

3. I was the natural brother of Crispin Wilson DYE. He was three younger than I. In December, 1993, I was living at [REDACTED] Yorkeys Knob in Queensland. At this time my brother Crispin, was living at [REDACTED] Holloways Beach, which is the next to suburb from where I was living.

4. About the 20th of December, 1993, Crispin travelled to Cairns and then travelled to Sydney to spend Christmas with our mother, who at the time was living at Willoughby in Sydney.

5. On the 23rd of December, 1993, I received a telephone call from our mother advising me that Crispin was in a critical condition in St George Hospital. I then made certain arrangements and travelled to Sydney on the afternoon of the 24th of December, 1993.

STATEMENT (continued) in matter of :

6. Our mother picked me up at the airport and we travelled to the St George Hospital at Kogarah. We then attended the Intensive Care Unit where I saw my brother Crispin. At this time he was on a life support machine with serious head injuries.

7. After discussing my brother's condition with the doctors treating him, my mother and I requested that the life support machine be turned off. The life support machine was subsequently turned off about 6.30pm on the 25th of December, 1993. Crispin died shortly thereafter.

8. A short time later I spoke to a Police Officer and made a formal identification of my brother in the intensive care unit of the Hospital.

9. I returned to my home in Queensland on New Years day and a couple of days later I went to Crispin's address and saw that there was a package in his mailbox. On opening the package, I saw that it contained Crispin's Frequent Flyer card and a number of other cards belonging to Crispin. I saw that it had been sent from a post office in Sydney. I then contacted Detectives at the Surry Hills Police Station and informed them. I then carefully placed the cards inside an envelope, only touching the cards on the edges. I then placed this envelope inside another envelope and sent to Surry Hills Police Station by certified mail.

10. Some time later I contacted Detective Sergeant KNIGHT at Surry Hills Police Station and informed him that a diamond and gold ring belonging to Crispin had not been located with his possessions and appeared to be missing.
