 NEWMARKET POLICE IN AUCKLAND CONCERNING
 EVENTS THAT HAPPENED IN SYDNEY AUSTRALIA
 ON THE NIGHT OF WEDNESDAY 22ND OF
 DECEMBER 1993 CONCERNING A PERSON BY
 THE NAME OF CRISPIN DYE.

I KNOW CRISPIN AS HE WAS MY BOSS, I
 USED TO WORK FOR HIM ABOUT SIX MONTHS
 AGO AT HIBISCUS LANE PRODUCTIONS IN
 SYDNEY. CRISPIN HAD RANG A COUPLE OF
 DAYS PRIOR TO WEDNESDAY TO ARRANGE
 A TIME TO GO FOR A DRINK. I WAS
 LEAVING SYDNEY ON THURSDAY 23RD
 DECEMBER 1993 TO RETURN TO NEW
 ZEALAND. I WAS STILL LIVING IN SYDNEY
 WHEN HE RANG ME.

ON WEDNESDAY 22ND AT ABOUT 5:45PM
 I MET CRISPIN AT THE BELLEVUE
 HOTEL IN NARCRAVES STREET PADDINGTON
 WE HAD A FEW DRINKS AND DINNER
 THERE AND MOVED ON TO THE
 PADDINGTON INN WHICH IS IN OXFORD
 STREET, PADDINGTON. IT WOULD HAVE
 BEEN AROUND 8:10 PM WHEN WE GOT
 THERE. WE BUMPED INTO A FRIEND
 OF MINE JANE WILKINSON, I THINK THAT

HER LAST NAME AND HER FRIEND
 HAMISH. I DON'T KNOW HIS LAST NAME

 JAMES MACALISTER MY COUSIN WAS
 WITH US AT THE PADDINGTON INN AND

 HAMISH TO GILLIGANS. WE WERE UPSTAIR
 FOR AN HOUR AND CRISPIN WENT
 DOWNSTAIRS TO A POOR BAR CALLED
 OXFORD TAVERN. WHILE WE WERE
 UPSTAIRS BEFORE CRISPIN LEFT JAMES'
 GIRLFRIEND JO ARRIVED, ABOUT 1:00AM.
 1:30AM JANE HAMISH AND MYSELF
 WENT ACROSS THE ROAD TO THE
 COURTHOUSE TAVERN. JAMES CAME WITH
 US ALSO. I CAN'T REMEMBER IF JO WAS
 WITH US. FROM THERE I WENT HOME
 TO JANE WILKINSONS PLACE, THIS WAS
 ABOUT 2:30AM. I DID NOT SEE
 CRISPIN AGAIN AFTER HE WENT
 DOWNSTAIRS.
