
2. My age is 21.

3. About 4.35am, Thursday the 23 December 1993, I was driving to work at Roseville. I was driving north along Flinders St, then turned into Campbell Street and stopped at a red traffic light at the intersection of Campbell and Bourke Streets, facing west.


4. Whilst stationary at the lights, I saw 3 men on the northern side of Campbell Street near the intersection of Little Oxford Street. They were standing around a large object which was laying on the ground and were picking it up slightly and moving it around.

5. As I moved off from the lights and headed west in Campbell Street, these 3 men appeared to grab something from the object. After this, they started to run west in Campbell Street along the northern footpath. I slowly drove towards the object and when I got near, I saw that it was a man laying face down on the street. This man wasn't moving.

6. I immediately decided to look for a Police Station to report the matter so I drove down Campbell Street and turned north into Crown Street. As I did so, I saw the 3 men running across Crown Street. They then ran west into Goulburn Street. I continued ahead to Oxford Street and drove around the block.


7. When I re-entered Oxford Street, I drove west and noticed these 3 men walking in a westerly direction along the southern footpath of Oxford Street, just east of Pelican Street. I continued past them, turned left into Pelican Street and located Surry Hills Police Station where I told Police what I had seen.

8. I would describe the first of these 3 men as about 17-18 years old, Islander appearance, about 180cm tall, slim to medium build with a dark complexion. He had shoulder-length black hair and was wearing long baggy pants and a T-Shirt.


9. I would describe the second man as about 17-18 years old, Islander appearance, about 180cm tall, slim to medium build with a dark complexion. He had shoulder-length black hair and was also wearing long baggy pants and a T-shirt.

10. I would describe the third man as about 17-18 years old, Islander appearance, about 180cm tall, slim to medium build with a dark complexion. He was wearing a dark-coloured baseball cap, grey-coloured, knee-length, baggy shorts, white socks, joggers and a T-shirt.
