- This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 2. I am 23 years of age.
- On the evening of Wednesday the 22 December, 1993, I went to the 'Bentley Bar in Crown Street, Surry Hills to have a few drinks with some friends. About 3am I then caught a taxi to Kings Cross to meet some friends at the 'Jet Black' Night club but it was closed. I then went to the ANZ bank in Darlinghurst Road, Kings Cross and withdrew \$40 so I could get something to eat and have enough to catch a taxi home.
- Shortly after 3am, I walked south in Darlinghurst Road and turned right into Victoria Street and walked north and then walked down the set of stairs not far from the 'Jet This set of stairs led me to Brougham Black' Nightclub. Street and I continued walking north in Brougham Street with the intention of going to 'Harry's cafe de wheels' for something to eat.
- I was walking to the left hand side of the road and I had 'Harry's cafe' in sight when I heard a noise coming from

behind me. I began turning around to my left to see what was happening and the next thing I knew I was lying in the middle of the road with people around me and a man from 'Harry's' called 'Ron' was talking to me and holding me to try and keep me conscious. I do not recall being attacked because I must have lost consciousness due to one of the blows to my head. I did not see any of the persons who, I have since learned, attacked me.

- 6. At this point I realised I had been attacked and I could see blood all over my arms. I felt very uncomfortable and I could feel that I had been hit to the left side of my eye/temple. I also realised my wallet had been taken from me. An ambulance arrived shortly after and they placed a neck brace on me and took me to the St Vincent's hospital.
- As a result of being robbed I sustained a 5cm laceration to the left eye/temple area which has received at least 12 stiches. I also received a broken nose and associated pain, swelling and bruising and small abrasions on my nose. On the right side of my forehead I have got bruising and swelling as a result of some sort of blow. Similarly, I have the same to the bottom right side of my head. I have abrasions to the right side of my forehead, just above my right eye. Both top and bottom front teeth have been chipped. I have swelling and pain to my whole jaw. I also have significant pain, swelling and bruising to my left cheek bone.
- 8. I had my wallet taken from me which was black leather and contained; \$50-\$54 in cash and coins, 1 ANZ Gold Visa card, 1 Westpac cashcard, 1 Driver's licence in my name and other personal papers.
- 9. At no time did I give any person or persons permission to rob me and cause the injuries I have stated above, to me.
