INVEST. Murder of Crispin DYE

On Saturday, 22/01/94, after receiving information from the victim's brother, Brenton DYE, that the victim, Crispin DYE's Ansett Frequent Flyer card and Health Benefits card had been posted to his home address in Cairns from Darlinghurst on the 23/12/93, Task Force Investigators attended the Ansett Travel office at the cnr of Oxford & Riley Streets, Darlinghurst. Investigators spoke to the acting Manager, Mr Ryan McKEAG. He stated that no records were maintained relating to any property or cards etc. that had been handed to staff as lost property. Inquiries were made with staff on duty at this time, however no staff had any recollection of receiving the property or mailing it to Cairns.

On Thursday, 27/01/94, Detective MILLIGAN attended the Ansett Travel Office, Oxford & Riley Street, Darlinghurst and spoke to the acting Manager, Mr Les KEMP in regards to the victim, DYE's Frequent Flyer card and Health Benefits card being handed in to staff on the 23/12/93. He was shown the envelope in which the Victim's property had been mailed to Cairns, and identified the handwriting as belonging to one of his staff, M/S Karen STUART, who was at the time in London on holidays and due to return on the 7/2/94.

On Monday, 07/02/94, Detective MILLIGAN attended the Ansett Travel Offices, Oxford & Riley Street, Darlinghurst and spoke to M/S Karen STUART in relation to the victim's Ansett Frequent Flyer card and Health Benefits card that had been mailed to Cairns. She was shown the mailing envelope and confirmed that she had addressed the envelope and placed in the mailing tray. She stated that she was unable to recall the property being handed in but believes she picked it up from a tray on the front counter where it could have been left by any member of the public during business hours. Investigators also made further inquiries with all staff members who were working on the 23/12/94, however none could recall the property being handed in by any person.
