Further to the below, I am instructed that the extendable baton was seized at some point during the course of the original investigation, possibly as a suspected murder weapon, although I note the coronial brief suggests the injuries were more consistent with a square rather than a circular weapon.

In the circumstances, NSWPF have made arrangements for the transport of the baton together with the remaining exhibits to FASS for testing as requested.

I'll write to you separately in relation to the Rose matter.
