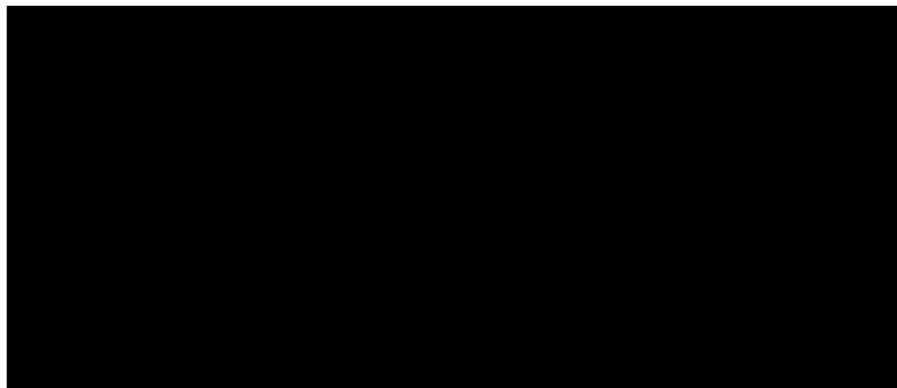

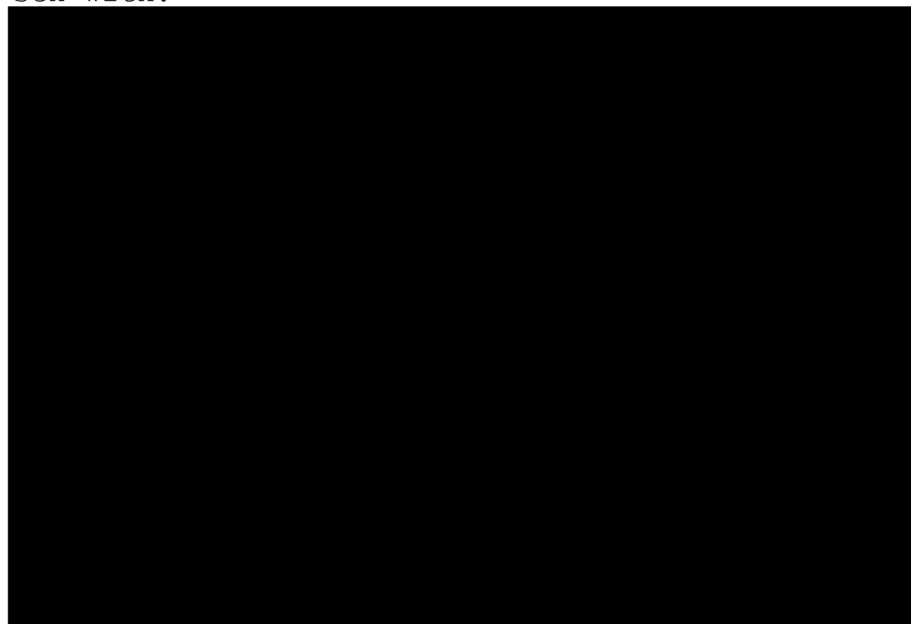

* POI 14 used to impinge on POI 11's hospitality staying at his Earlwood flat for days, often rolling around on the floor covered in baby oil.
* Other paedophiles POI 1 met at POI 11's residence in Earlwood were POI 15, a prominent figure in POI 11's life. [REDACTED]

[REDACTED] Penrith detectives frequently attending POI 11's residence at LOC 2 looking for POI 15 who brought boys there to have sex with.



* POI 11's closest friend was allegedly POI 22, a producer of boy porn videos. POI 1 met POI 22 once but POI 11 spent a lot of time at POI 22's address and showed POI 1 movies that POI 22 had produced, POI 11 and POI 22 having video cameras.



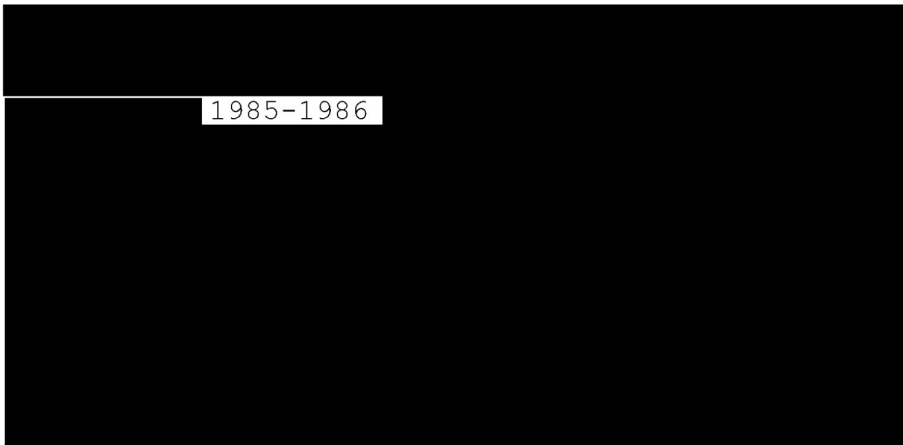
