It's nice to hear from you and hope you are well. I am more than happy to give you an update.

Over the past six months the NSW Police Unsolved Homicide Team has been committed to a Special Commission of Inquiry into LGBTIQ deaths currently being conducted here in Sydney. This is a well-publicised Inquiry examining historical homicides and suspicious deaths in New South Wales.

I inform you of this not because [REDACTED] death falls within the scope of this inquiry (it doesn't), rather the resource commitment required from both me and my team over the past six months to this Inquiry. This commitment should however dissipate in the coming months.

Notwithstanding my commitment to this Inquiry, when time has permitted I have continued the review into [REDACTED] death. The review is still very much active and remains with me.

The material I have reviewed thus far and, in my view, conveys a clear set of circumstances surrounding [REDACTED] death. That said, there is still a significant amount of material I need to review before a conclusion can be reached and a recommendation made. Every holding needs to be meticulously reviewed but the consequence to this is the time it takes to ensure this is undertaken comprehensively.

Like I have previously communicated to you [REDACTED] review will remain active and with me until it is completed by me. I can assure you the review is not going to disappear. Should there be any developments or changes, rest assured I will reach out to you, but please keep the communication between the two of us confidential.

The review into [REDACTED] murder I am working on exclusively and daily. It is my only focus.

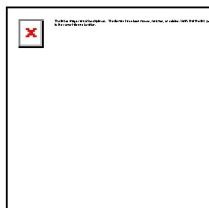
I can assure you the review won't suddenly disappear leaving you without answers. I will be working on the review until complete.
