I asked Margaret whether she thought it was serious enough for me to go to Alan's place to whether he was alright as I told her if she thought so I had a key at the shop that would let us in to his flat. She said that she thought it was because it was very unusual for Alan not have contacted her as he had promised to take her out on the previous Saturday night and that she had gone to his flat on the Saturday morning and left a note on his door to remind him. She went back to the flat the next day and the note was still there and that she thought that the door had not been opened. This worried her because she noted there was a light on in the flat. He had also promised to come into work although he was on vacation to help her do some work for the credit union that day, Tuesday, 22nd June, 1976, and he had not turned up. All these events were uncharacteristic of him. I then satrted to beco become worried myself and I asked my wife who was listening to the conversat tion whether she thought I should go and see whether everything was alright. My wife said to please myself so I then decided for everybody's peace of mind, I would go and see if everytting was alright.

6. I was in my pyjamas at the time ready to go to bed so I got dressed. I told my wife that I was going to go and get [454] and that if he rang back to tell [454] that I was on my way to pick him up. I then proceeded to [454], Brighton, where I picked [454] up. He was dressed at the time and I could tell that he had been drinking. I told [454] that I decided I'd take him over to Alan's place to see if everything was alright. He gathered up his wallet and things and said 'Something's happened to him, I feel something has happened to him." But [454] is the sort of bloke that when he's had a few drinks, he's a crying type of drunk, he's really down...he always thinks the worst of everything. I didnet take any notice of him because, as I said, he's always like that.

7. It would be about twentyfive past eleven we left Tony's place in my car. My car is a finite weak of the registered number is finite. We drove to my shop at finite many, and the registered number is finite. We drove to my shop at finite many, Balmain, to pick up the keys to Allan's flat which I kept there in the cash register. I speeded up a bit because I was anxious and I got there about a quarter to twelve. (Surname in capitals) At Alan's flat I used the keys to open two locks on 8. the door; one is a dead lock type and the other is the sort they are putting on all the doors these days. I pushed the door open and just peered in and saw that the light was on but the room itself was undisturbed. We both then entered the loungeroom and looked around. Everything was tidy and seemed to be in it's right position. I then noticed that the kitchen door was closed. The kitchen door is just on the right hand side as you enter the front door. I called out Alan in case he was in the bedroom but there was no answer so 1454 pushed the kitchen door open. I can't think whether he just pushed it or opened it. The door swings back around to the right and I got a sort of a side on view of a body lying on the floor. I only saw the buttocks and the legs. I know that 1454 's emotional and to sort of stop him from seeing it or doing something I stepped in front of him and as I did so I peered in into the kitchen which was in darkness and I could shen see that it was Alan HEAD lying on the ground. I knew straight away that something was wrong and I did not know what 1454 would do and that is the reason I steppe -ed in front of him and put my arm out to stop him from going any further into the kitchen. Is the blood on Alan's body and I can't remember what I said nor what 1454 said just stunned I suppose.

On the way over to Alan's flat I was thinking what 9. would I do if something was wrong and I then remembered that Alan had told me that the man in the flat opposite his was a policeman. If there was anything wrong I could go straight auross and get him. So just by instict I proceeded across the hall to the policeman's flat. Before I got to the Policeman's door, it was opened by a lady who I presumed was the Policeman's wife. She then asked me was Alan alright and I said 'NO! I think he's dead." She then said, that she was worned and that she thought something might have been wrong as she had not seen Alan for two or three days. The last time she heard him was on the previous Thursday night when she had heard a terrible argument coming from his Flat. She had heard somewody cry out, that sounded like Alan, saying 'Please don't hurt me any more. ' Her husband had called out to Alan asking him whether he was alright. She thought he answered 'Yes.' She told me she heard somebody leaving and it sounded as if two people went out together.

10. This conversation took place in the Policeman's flat as the lady had asked/into her flat. I had already pulled the door to on Alan's flat as we were coming out. I didn't know what to do. The lady then told me that her husband was due home any minute and to wait and he would contact the Police. The Policeman was a little bit longer coming home than I had anticipated and meanwhile there was some further

11. The Policeman arrived home about twenty minutes after we had gone into the woman's flat. I then took him into Alan's flat where he observed the body and looked around the rest of the flat. We then went back to the Policeman's flat where he rang the Police. We stayed in his flat until the arrival of two uniformed Policemen. The two uniformed Police, the off duty Policeman and myself went back into Alan's flat. The uniformed Police just looked at the body, went to the other rooms and shone the torches around and then we all went back into the Policeman's flat where the uniformed Policeman rang you fellows I suppose.

12. Allan was an average sort of drinker. He liked to entertain, he he liked visitors. If you went there he'd always offer you a drink. He didn't smoke habitually but on occasions I have seen him smoke at a party. I did notice the ashtray in his flat tonight when I walked in because I wondered where all the cigarettes came from because I knew that he didn't smoke. He always smoked tailor mades, never roll-yourowns-. He drank beer in the hotel and Rose at home.

13. Allan was always immaculate, shirts pressed, not a hair out of place, always spic and span. Alan introduced me to a lot of men friends. They were mostly the direct opposite to his character. He was the prim and proper type and they were the rugged type. I just took them as casualaquaintances and I can't recall their names.

14. Allan was a bit of a gambler. He used to like to gamble on the horses and dogs. He bet on the tote numbers. Played the poker machines. He was in some financial trouble. He used to bet too much money at times and in my opinion more than he could afford. I have lent him money at times up to \$60 but he always paid me back.

15. The reason I had a key to Allan's flat in my possession was because Al an had always left a key with me in case he lost or forgot his own. I had the keys to his Balmain Flat for the same reason for about six years all told, I suppose. When he bought this new flat he just continued with the same arrangements. He had lost keys to his flat at Balmain on a number of occasions.

16. I don't think that there is anything else that I can say. I am prepared to attend Court if necessary to assist. I can think of no person who would want to kill Allan for I never knew him to have any enemies.
